REPORT OF THE BOARD OF DIRECTORS OF MINERS' HOSPITAL
NO. 3.

To His Excellency HON. W. M. O. DAWSON, *Governor of West Virginia
Charleston, West Virginia.*

SIR:—According to custom and in compliance with the laws by which we are governed, the Board of Directors of Miners' Hospital No. 3, respectfully submits this their third biennial report, together with the reports of the Superintendent, the Secretary and Treasurer, for the years 1904-5-1905-6, and in doing so the Board would reiterate, what it was pleased to say about this institution in its last biennial report, and would add thereto its mead of praise for the manner in which the affairs have been conducted. It was wise of the Legislature, at its last session in making the appropriation which it did, for the improvement and the enlarging of the building, thereby increasing the capacity, for taking care of those unfortunates who are the victims of the terrible accidents, which so often befall men who are engaged in the hazardous occupations of Railroad, Mining and the handling of Factory machinery, and who after becoming the recipients of the beneficence of the State, though in many instances maimed for life, bear in grateful remembrance, those who made it possible for them to receive the skillful surgical treatment, and the careful and tender nursing, which saved their lives and restored them in health to their friends and families.

Your Board has, at stated intervals, visited and inspected this institution over which your Excellency has given us the control, and we have on all occasions found it fully up to the requirements. We most highly commend the executive management, for the manner in which the business affairs of the institution have been conducted, in the judicious expenditure of the funds appropriated for the improvement of, and the maintenance of the hospital, no less do we commend those in charge for great kindness manifested towards patients of the institution, as well as the skillful treatment given them, and the great care and attention shown them.

We herewith submit the monthly reports of the Superintendent and the recapitulation for each year.

SEPTEMBER 30, 1905.*

GENTLEMEN:—I have the honor to submit the following report of the work of the hospital for the fiscal year ending September 30th, 1905.

23 patients were in the hospital on the first day of October, 1904, 219 have been admitted, 208 dismissed and 9 died, leaving 25 in on the first day of October, 1905.

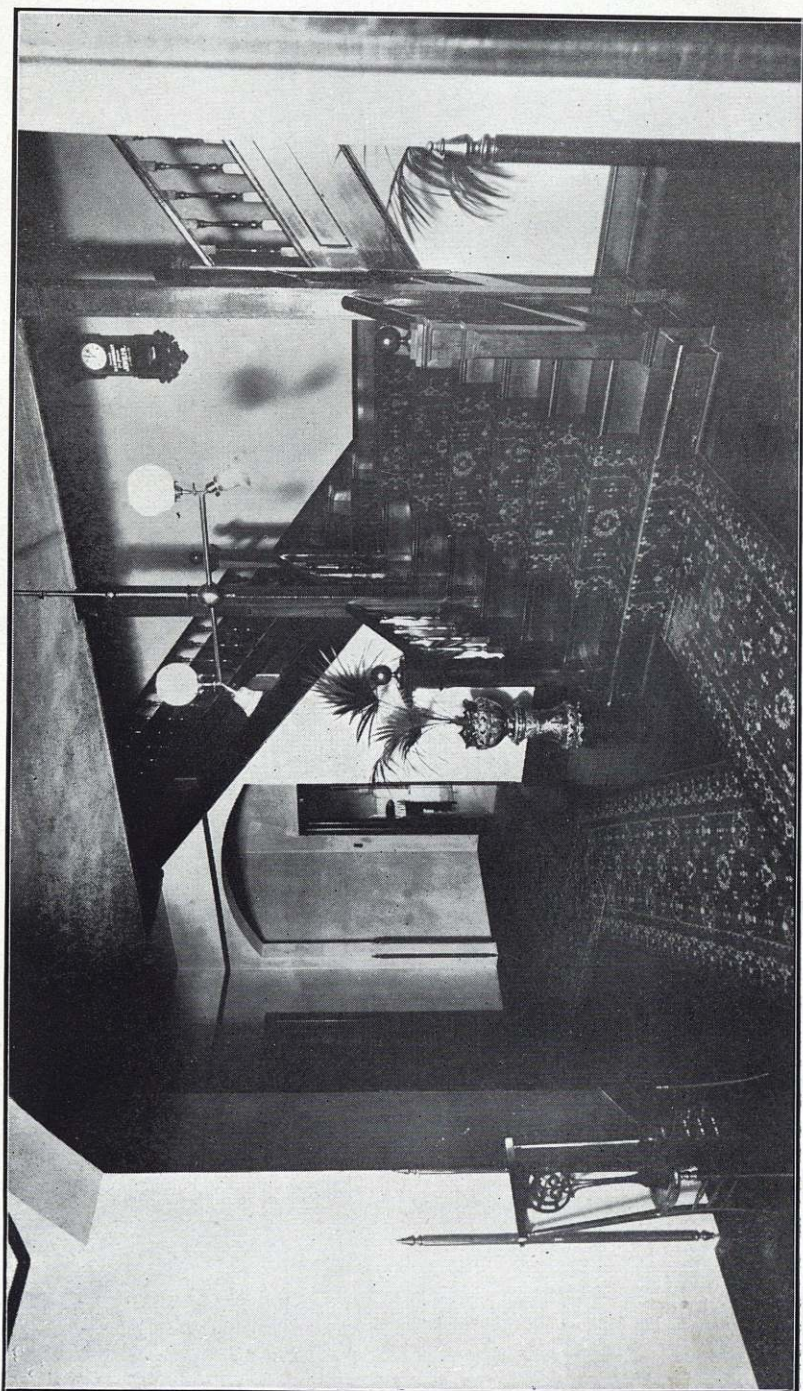

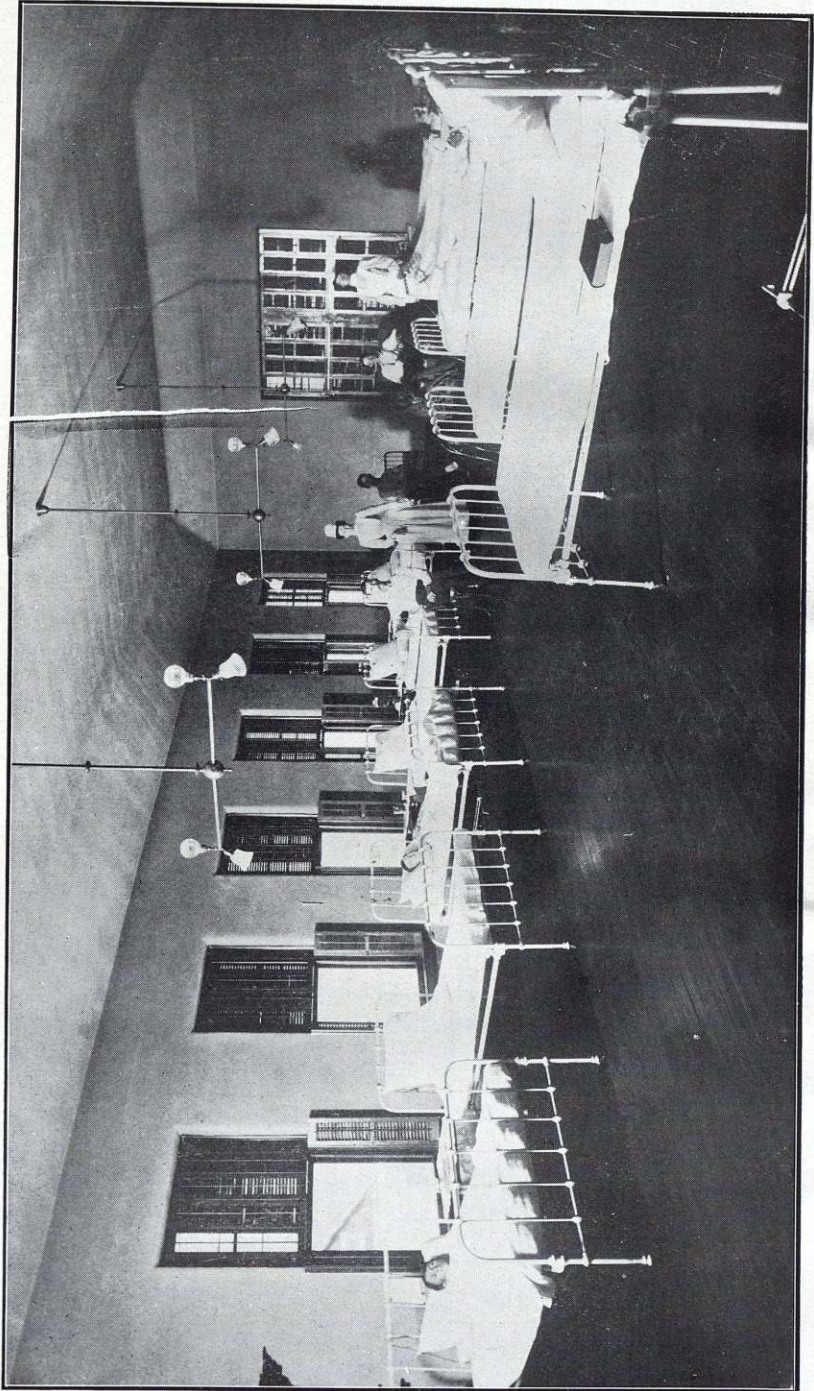

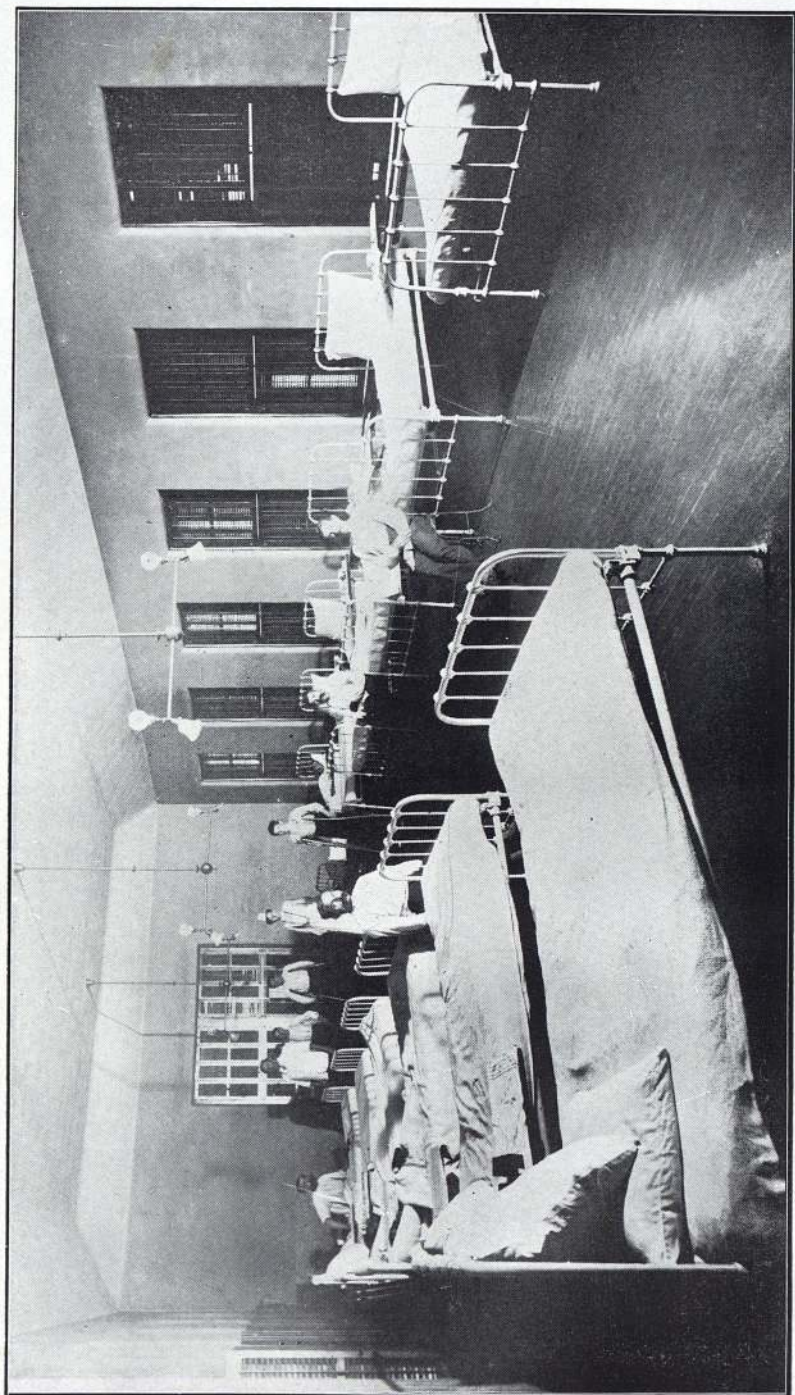

It gives me pleasure to say that with the completion of the improvements to the building (giving us twenty private rooms), the installation of the elevator and with the grading and paving of our roadways we now have a building of which we can be proud, it meeting all the requirements of the purpose for which it was intended and of sufficient capacity to care for those entitled to its service in a manner which will be productive of better results and to properly handle and care for the class of patients brought in.

You will notice by the Clinical Report of cases that we have had more patients than ever before and also the increase in the number of days service. The admitting diagnosis shows the gravity of the cases and from these you can judge of the amount of work done in treating and caring for them.

Our Training School for Nurses has proven even more successful than in former years and it is gratifying to note the success attained by our graduate nurses in their chosen profession.

On June 22, 1905, Misses Hannah Huntsman, Mae Harr and Mrs. Frances Duer and on June 18, 1906, Misses Nellie Casteel and Matilda Carpenter having completed the course and satisfactorily passed the final examinations were granted diplomas certifying to their qualifications as trained nurses.

There is no deficit in either of our two accounts, Maintenance and Improvement and Repair and we owe nothing.

For the next biennial term we will need \$17,500.00 per annum for maintenance if it be understood that the term maintenance would include items of minor repairs, such as painting and of purchase of necessary furniture such as beds, etc.. We are unable to use several of our rooms because of lack of furnishment.

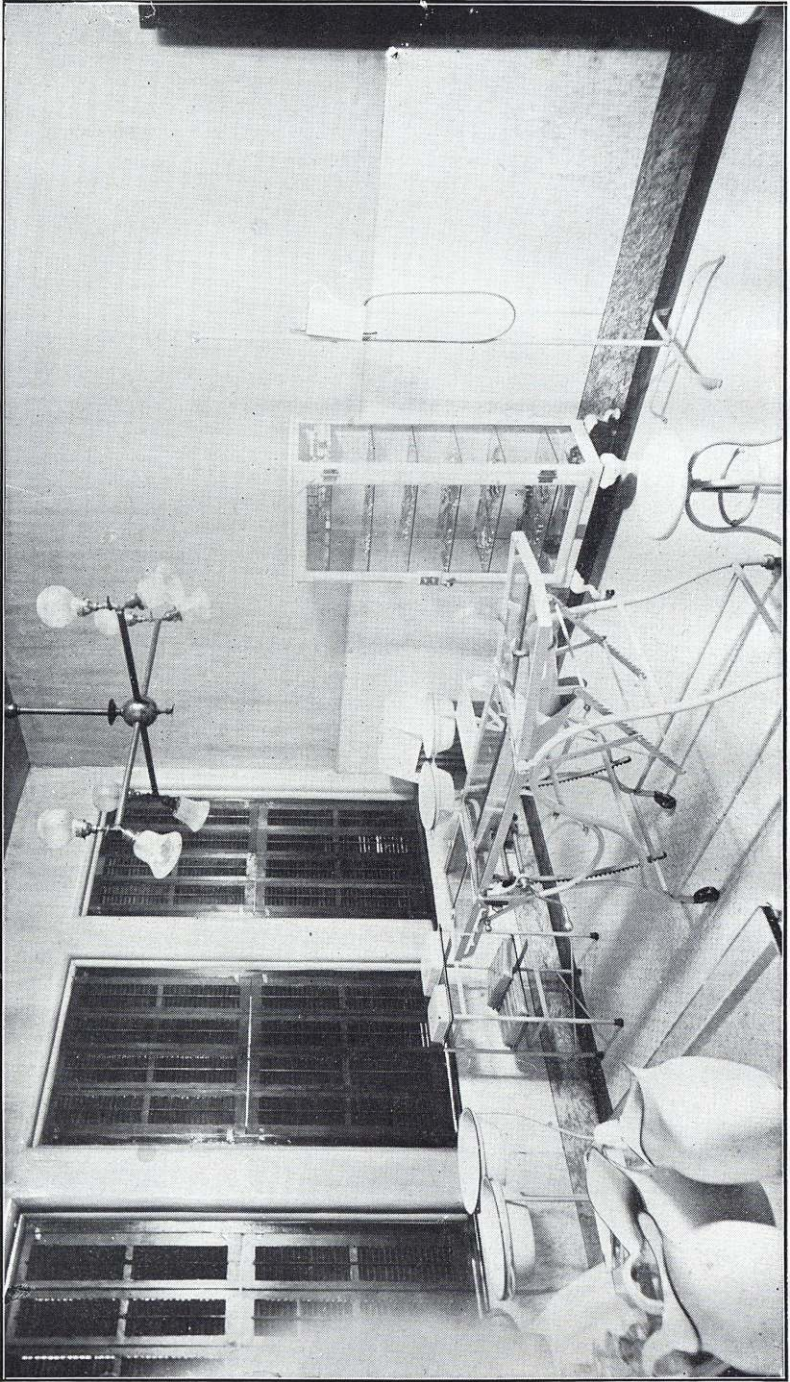

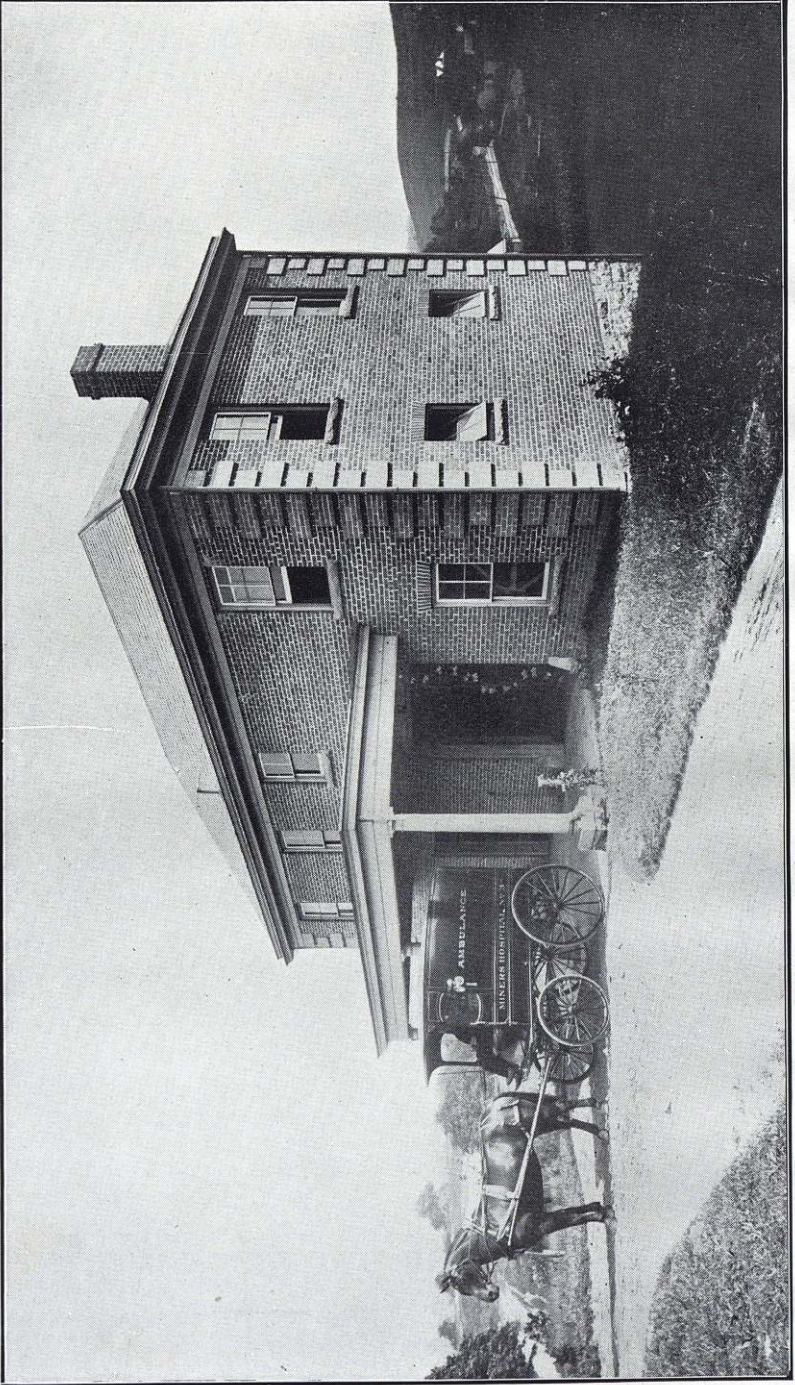

At a meeting of the Board of Directors of Miners' Hospital No. 3, held in the office of the Superintendent, on the 8th day of October, 1906. It was ordered that the reports of the Superintendent, the Secretary and Treasurer be approved, and made a part of the report of the Board, to His Excellency the Governor.
