

THIS DEED, Made this 29th day of May, 1917, by and between the Buffalo Land and Coal Company, a corporation organized and existing under the laws of the State of West Virginia, party of the first part and Pocahontas Coal and Coke Company, a corporation chartered and organized under the laws of the State of New Jersey and authorized according to the laws of the State of West Virginia to hold property and do business in that State, party of the second part; and Norfolk and Western Railway Company, a corporation chartered and organized under the laws of the State of Virginia and authorized according to laws of the State of West Virginia to hold property and do business in that State, party of the third part;

Witnesseth: That for and in consideration of the sum of One Dollar and other valuable considerations in hand paid, the receipt of which is hereby acknowledged, the party of the first part does hereby bargain, grant, sell and convey unto the party of the second part, with covenants of general warranty, the following described lots, pieces or parcels of ground, situate in Lee District, of Mingo County, West Virginia, on Tug River, and on the waters of Buffalo Creek, said tracts or parcels of land are more particularly described as follows:

Tract No. 1.—A tract of 63 7/10 acres of land situate on Buffalo Creek of Sandy River in Mingo County, West Virginia, bounded and described as follows:

Beginning at a sugar (stump) at top of ridge on north side of Buffalo Creek on back line of the Thompson and Webb 335 acre grant corner to Hatfield and Cantrell and down the ridge S. 49½ W. 809 feet to a hickory, corner of said grant, S. 38 W. 96 feet to a stake near three cherry trees on said ridge on line of said grant corner to Hatfield's lower tract, and with latter through the Thompson lands S. 12¼ E. 2351 feet, crossing Buffalo Creek at stake at corner of fence, agreed division corner in Thompson partition, to a stake on south side of creek on outside line of the Slater tract and with same and lands of R. Beginning at a sugar tree (stump) on ridge between Caney Fork and Dan's Branch on outside line of a 335 acre survey granted to Thompson and Webb and corner to Hatfield and Polly Evans, and with the latter through said grant and 227 acres granted to John Thompson and 100 acres granted to James Slater S. 22½ E. 2960 feet crossing Buffalo Creek at a gum, division corner in Thompson partition, to a stake on back line of the Slater tract and with same N. 82½ E. 980 feet to a stake on same corner to Walton and O'Keeffe, and with same N. 15½ W. crossing Buffalo Creek at an apple tree, division corner in Thompson partition, 2090 feet to a stake on Hatfield's line, and with same N. 69 W. 1650 feet to the Beginning.

70 acre and 98 acre grants, S. 39 E. 853 feet, crossing Buffalo Creek, to a stake on line of 98 acre and 138 acre grants, and with same S.  $45\frac{1}{2}$  W. 1376 feet to the BEGINNING.

Doolittle, his wife, by deed bearing date the 24th day of January, 1903, and recorded in the office of the Clerk of the County Court of Mingo County, West Virginia, in Deed Book No. 11, at page 54.

All the right, title, interest and estate of the party of the first part, in and to that tract of 27.75 acres situated on Cold Water Hollow, a tributary of Buffalo Creek in Lee District in Mingo County, being the same interest in said land which was conveyed by the Howard Colliery Company to the party of the first part, by deed dated the 18th day of April, 1914, and recorded in said Clerk's Office in Deed Book 30, page 224, to which deed and the record thereof reference is made for a more complete description, and to the terms and conditions of said deed of April 18th, 1914, subject to the terms of a lease to the Norfolk and Western Railway Company bearing even date herewith.

Together with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining.

And the Norfolk and Western Railway Company as a further consideration of the release of the payment of any future royalties or rentals under said leases covenants to pay all taxes which may from time to time be assessed and charged against the said land and minerals thereunder.

but does not include any moneys now on hand in the treasury of the Buffalo Land and Coal Company, or money due it on account of royalties to April 19, 1917.
