

# **Bistory** and Location

# The Spring and Surroundings

The spring is about seventy-five yards from the new modern hotel, just completed a few years ago, and from seventy-five to one hundred yards from the five furnished cottages. The spring has been improved by placing over and around it an octagon pavilion concrete base, with sparkling water boiling up in the center as clear and pure as crystal. # Ibotel and Cottages

## The Table

The table will be provided with fresh garden vegetables and fruits in their season, obtained from near-by farms and hotel farm and garden. Will also have fresh country eggs, sweet milk, cream, buttermilk, butter and meats, furnished from hotel farm. For the invalids who require light diet, cereals, fresh sweet milk, etc., will be furnished—the management realizing that in any treatment a great deal depends upon proper dieting. The water gives to those drinking it a ravenous appetite, and persons whose stomachs refuse to digest solids and heavy foods, find after using this water, as they express it, "We can eat anything."

As varied a menu as possible will be furnished, and all that good cooking and dainty serving can do, to help along the good effects of the water, will be done, it being the desire of the management to do all in every department to make it pleasant for the guests, and above all, that those seeking health from the use of the water may have every additional aid in their power to give.

Princeton, four and one-half miles from the Springs, is the county seat of Mercer County. Post office "Mercer Healing Springs" will be opened in Hotel after June 22d.



# Mow to Get to the Springs

There will be regular hacks and automobiles to meet all trains at Princeton, the nearest railroad station, on the Virginian Railway. Charges will not exceed fifty cents each way for each person, and fifty cents for trunks, provided you be careful to engage regular conveyances making regular trips to the Springs.

Parties desiring to come through the country from Bluefield—sixteen miles—can do so by taking either the regular daily hack or automobile from Bluefield to Princeton, and change at Princeton to daily hack or automobile from Princeton to "The Springs"; or, better still, if they will in advance write to or call up Mercer Healing Springs Hotel by long distance 'phone, we will send hack or automobile direct from Springs to Bluefield; by doing so we will see that charges are reasonable. The fare from Bluefield to Springs will be not over \$1.50 each, when two or more are in party. Always before taking conveyance from either Princeton or Bluefield to the Springs, make contract as


