## INTRODUCTORY.

NO TITLE in any estate can with safety be taken without careful investigation of the records; and none should be taken without the opinion of a competent and reliable person as to its validity. There is no state in which fraud or deception cannot be practiced successfully upon the negligent or indiscreet purchaser."—Hutchinson's Land Titles.

No person should purchase real estate without first having a thorough examination of the title made from the time of the grant by the Commonwealth to the present owner.

Transfers in the early history of our state were made without much regard to legal requirements and many conveyances are shown by the records to have been prepared by incompetent persons.

Very often serious litigation has arisen resulting from such negligence.

Short period examinations do not disclose all defects and no property

can be purchased with safety without a complete examination of title.

Title examining is a distinct branch of the law and many intricate questions are passed over by those unfamiliar with the technicalities arising under the laws of the State in which the property is situate.

Experience is the best teacher for the title examiner and no person is a competent examiner of titles who is not thoroughly familiar with real estate law.

The examination of titles to real estate has always been a source of vexation and very little profit to the legal profession.

The West Virginia Abstract and Title Company aims to remove this source of vexation by relieving the practicing attorney of the burden of work incidental to abstracting, while insuring to him a reasonable profit therefrom.

Abstracting is comparatively a new departure in our State.
