the 3-18th undivided interests of N. W. Sollenberger in the following tracts of land, to-wit:

One tract of 9247 3-8 acres and one tract of 71 acres.

These two tracts adjoin each other, and are situated in "Canaan" in the Alleghany mountain, in the counties of Grant and Tucker (principally in the former) within 6 or 8 miles of "Fairfax Stone" and on both sides of Stony River, and on the Beaver prong of Black Water and adjoins the lands of McMechen, Grove, Gatzmer, Davis and others, It is entirely unimproved, but very valuable for its immense deposits of excellent Coal and quantities of valuable Timber.
